

OFFICIAL RULES FOR PROMOTION

Promoted by Team Dignitas for itself and on behalf of its affiliates (collectively, “TEAM DIGNITAS”)

PROMOTION IS VOID WHERE PROHIBITED. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY. PROMOTION DOES NOT REQUIRE A PURCHASE OR PAYMENT TO ENTER OR WIN AND A PURCHASE OR PAYMENT WILL NOT INCREASE THE CHANCES OF WINNING.

By entering this Promotion, you (the “Entrant”) accept and agree to the Official Rules including all eligibility requirements, and decisions arising out of this Promotion by TEAM DIGNITAS.

PROMOTION PERIOD

The Promotion begins on Friday, April 6, 2018, at 12AM Pacific Time (“PT”) and ends on whichever is the earlier of, the completion of all tournament rounds or Sunday, May 6, 2018 at 9PM PT. The Sign-up period will begin on Friday, April 6, 2018 at 12AM PT and will end on Monday, April 30, 2018 at 11:59PM PT. The Tournament Play period will be from May 5, 2018 at 12:00PM PT and will end on whichever is the earlier of, the completion of all tournament rounds or Sunday, May 6, 2018 at 9PM PT. TEAM DIGNITAS may terminate, extend, or suspend the Promotion in their/its sole discretion.

HOW TO ENTER

During the Sign-up period the Entrants must either create or login to their current PLAYERUNKNOWN’S BATTLEGROUNDS account at <https://battlefy.com/chickendinneropen>. Entrants must then join the ‘Chicken Dinner Open’ by clicking the ‘join’ button on the same website. Entrants must be logged into their account during the Tournament Play Period.

ELIGIBILITY

THE PROMOTION IS INTENDED FOR ENTRY IN THE FIFTY UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY (INCLUDING UNITED STATES MILITARY PERSONNEL OR CONTRACTORS ENTERING FROM WITHIN A U.S. MILITARY INSTALLATION). **Void in Puerto Rico, the U.S. Virgin Islands, all other U.S. territories and possessions, and where prohibited by law.** Entrants must be at least eighteen (18) years of age at time of entry, have a valid “PLAYERUNKNOWN’S BATTLEGROUNDS” account. The following are ineligible to enter the Promotion: Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for TEAM DIGNITAS, the prize partner Buffalo Wild Wings, Inc. WINNER SELECTION

For each round of play there will be one (1) winner (each a “Round Winner”). Each Round Winner will be determined by the Entrant with the highest rank for each round based on the in-game ranking.

Entrants will be separated into groups of up to one hundred (100) and participate in three (3) qualifying rounds of play each. Entrants finishing all three (3) rounds to completion and meeting eligibility requirements (each a “Valid Qualifier Participant”) are eligible for prizing. At the end of the qualifying rounds there will be up to one hundred (100) finalists determined based upon the highest total cumulative scores of the qualifying rounds based on the Legends Arena solo scoring system (each a “Finalist”). Finalists will have their scores reset and participate in an additional three (3) rounds of play. Finalists finishing all three (3) rounds to completion and meeting eligibility requirements (each a “Valid Finalist”) are eligible for additional prizing. The Finalist with the highest total cumulative score at the end of the Tournament Play Period will be the Grand Prize Winner. The Finalist with the second highest score at the end of the Tournament Play Period will be the Runner Up.

PRIZE

Each Round Winner will receive one (1) twenty-five dollar (\$25) Buffalo Wild Wings® gift card. Entrants may receive this prize multiple times if multiple rounds are won. Multiple gift cards may be merged into a single card. The top ten (10) Finalists, based on the average scores at the end of the Tournament Play Period will receive one (1) Team Dignitas, Buffalo Wild Wings® co-branded backpack.

The Finalist with the third highest score based on the average scores at the end of the Tournament Play Period will receive one (1) one hundred dollar (\$100) Visa gift card.

The Runner Up will receive one (1) three hundred and fifty dollar (\$350) Visa gift card and a customized Team Dignitas jersey.

The Grand Prize Winner will receive, (a) one (1) five hundred dollar (\$500) Visa gift card, (b) a customized Team Dignitas jersey, (c) a meet and greet with the TEAM DIGNITAS PUBG team at a Buffalo Wild Wings location in Los Angeles area, and (d) a trip with one (1) guest to the E3 gaming convention in Los Angeles on March 12-14, 2018, including flights, two (2) nights in a hotel, a three day pass to the convention for March 12,13 and 14, 2018. ENTRIES

Entry into the Promotion is limited to one (1) entry per Entrant. Any entry received in excess of such limitation will be deemed void. Any attempt by a person to use multiple PLAYERUNKNOWN'S BATTLEGROUNDS accounts to enter in excess of such limitation during the Promotion will be void. All entries must be received within the time period stated above to be eligible to win the Prize. Late and/or subsequent entries will be disqualified. All entries become the property of TEAM DIGNITAS. PRIZE DETAILS
